Contractors

Contractors can work on the Estate Monday to Friday, 9am to 5pm. They cannot work on the Estate at weekends and during public holidays.

You can be a good neighbour and notify your neighbours that you have planned maintenance work in your property with start and end dates and preferably a contact phone number.

Contractors must sign-in at the Estate Office building on their first day of arrival and display their temporary visitor's badge throughout their time on the Estate. Contractors, without a visitor's badge may be asked to leave the Estate.

Security Guard & Mobile Patrols

Ousman, our Security Guard, will be on leave on Friday 25th December 2020 and Friday 1st January 2021.

Additional patrols (totaling 5 each day) of the Estate, will be taking place on 25th December 2020 and 1st January 2021.
