## **RECYCLING:**

Please make sure that you put items in the recycling bins and flatten any cardboard before putting it in the bins to preserve space. DO NOT leave it outside the bins.

#### **TRELLIS:**

If you wish to add a trellis on top of your garden wall, please make sure that you apply to the Estate Office for a Licence to Alter to have it approved.

#### **GARDEN SHEDS:**

If you wish to install a shed in your garden, it must be no higher than the height of the perimeter wall.

## **DRAIN BLOCKAGE:**

Please only put toilet paper down the toilet drain. Please DO NOT put wet wipes, kitchen towels, & sanitary towels down the toilet. Also, take care what you put down the drains in the kitchen and bathroom to avoid blockages. Cooking oil and especially fat should never be poured down sinks as it can easily cause blockages. To safely dispose of cooking oil, please put the cooled oil in a sealed container and place it in your waste bin. The cost of unblocking a drain due to any of the above will be charged to the resident.

#### **KEYS TO PROPERTIES:**

Your help is requested in enabling the estate to react quickly to emergencies in your property such as leaks. Please make sure that you give us a spare set of keys, especially if you are often away. All keys are kept securely in a coded system. Alternatively, please give us details of a nominated keyholder.

#### **BICYCLES ON ESTATE:**

It appears that some bicycles in the estate bicycle racks may have been abandoned. The office will be sending letters to the residents in the next few weeks to try and determine which bicycles fall into this category. These will then be removed. This will free up space in the racks for other residents.

#### **DOGS ON ESTATE:**

There have been several sightings of dogs without a lead on the estate grounds. This is prohibited. All dogs must be kept on a lead. Dogs seen without their owners will be assumed to have been abandoned.
